

Grant of rights for the publication on the USL Bonn's repository "bonndoc"

Version 1.1, April 2017 translation: July 2019

Preamble

As an institution of the University of Bonn, Bonn University and State Library (USL) runs a repository called "bonndoc" which is generally accessible via the World Wide Web. The publication platform is available for the members of the University and enables them to be globally visible with their research and results.

The following provisions regulate the concession of copyright powers, which the USL Bonn is required to be vested with, in order to add the publication to the repository and to make and keep it accessible.

Please note that this translation exists only for comprehension purposes. The agreement of the author to the text should refer to the German version.

- **1.** I grant the USL Bonn the non-exclusive, unlimited right to electronically store the above or before mentioned publication including any corresponding metadata and (if any) abstract.
 - Furthermore, I allow the USL to make the publication as well as the corresponding metadata publicly available. I will provide all metadata including the abstract of the document for the USL under the terms and conditions of CCO 1.0 Universal (CCO 1.0) Public Domain Dedication
 - (http://creativecommons.org/publicdomain/zero/1.0).
 - If there is more than one author, it is assumed that all authors agree to these terms when a publication is added to the repository. In the interest of all co-authors, I abandon the right to revoke my agreement unless there is a significant reason (which makes under consideration of all parties' interests the adherence to the agreement unreasonable).
- 2. The publication is stored in the same format as the one it has been delivered in. I grant the USL the right to make copies of the delivered document as well as to convert it into different electronical or physical formats, provided the archiving and/or the process of making it publicly available requires it and the content integrity is maintained.

- **3.** I entitle the USL to provide the delivered document for other non-commercial repositories for the purpose of archiving and/or making it publicly available. The repositories' operators acquire the same powers as vested in the USL.
- **4.** I empower the USL Bonn to index the full text of the submitted document, to include all index data in search indices for so-called resource discovery systems as well as to offer them for use. I further entitle the USL Bonn to provide operators (also commercial ones) of indices for resource discovery systems with the full text of the submitted document for the before mentioned actions
- **5.** I assure that I am the originator of the publication and that I have not yet transferred any rights of use or, if so, only in a way which does not stand in conflict with the entitlement according to no.1. I furthermore assure that no rights or legal statuses of a third party (in particular personal rights) are infringed by the publication of the paper.I commit to inform the USL immediately if the legitimacy is being contested or put into question.
- **6.** I commit myself to free the USL Bonn from any claims of third parties being made on account of the publication of the paper. If the USL Bonn has to make any payments for claim settlement, I will bear the costs. This does not apply if another situation results from legal relations between myself and the university (e. g. employment).
